ANNUAL MEETING

Thanks to those homeowners who showed interest in our association and attended our annual meeting. Congratulations to Katherine Line, the

winner of one free month's Association dues.

The one-page November newsletter included the new assignments for all Board members. Since there were no new nominees for two open Board opportunities, the previous members agreed to serve again but in different positions and liaison assignments.

REPEAT: WINTER PARKING

Woodbury rules for winter parking were included in the brief November newsletter; parking is banned on public streets from 2 to 6 a.m. from November 1 through April 1. On-street parking is also prohibited any time two or more inches of snow have accumulated, until the street has been completely plowed.

Please review the following winter specifications included in the A-1 Maintenance contract with Heritage Glen:

1. Driveways will be cleared after at least 1.5 inches of snow have accumulated.
2. Driveways will initially be opened up to allow access prior to 7:00 a.m. and 5:00 p.m. when continuous snow accumulation reaches 4 inches.

3. Driveways will be cleared within 8 hours of cessation for snow depths of 1.5 - 8 inches and within 12 hours of cessation for snow depths over 8 inches.
4. A snowfall lasting 24 hours or more with an accumulation of at least 1.5 inches will be cleared to allow access.
5. Driveways that become closed by the city plows will be opened near the street.
6. Sidewalk snow removal criteria are the same as for driveways, but sidewalks are generally cleared after the driveways have been completed.
7. A-1 Maintenance is not responsible for damage to any electrical cords which may be buried under snow on the sidewalks.
8. Sidewalk snow removal will be delayed if wind chill temperatures reach 25 degrees below zero until safer conditions prevail.

Homeowners remain responsible for removal of snow from:

- Sidewalks and driveways for accumulations of less than 1.5 inches
- Driveways due to parked cars
- Roofs, decks and patios
- Driveways or sidewalks caused by roof clearing
- Ice accumulation from water drainage on sidewalks, steps and driveways.

Please do not run electrical cords across driveways or sidewalks. If vehicles parked in the driveway prohibit

safe plowing without causing damage, plowing may be omitted.
